

國立臺灣師範大學國語教學中心外籍學員團體保險

(保險期間:2024/09/01~2026/08/31)

- 1. 投保對象:國立臺灣師範大學國語教學中心就讀之外籍學員,於註冊同時辦理投保。
- 2. 保險生效日:以每月1日為保險生效日。(加保資料之提供,以雙方議定之保單約定書辦理)
- 3. 保險費繳付方式:
 - 1) 正常班以三個月為1期,每人每期保費 276元
 - 2) 暑期班以二個月為1期,每人每期保費 184元
 - 3) 單月班以一個月為 1 期,每人每期保費 92 元

4. 保險內容:

備註:

- (1) 團體傷害保險:保障因意外事故所致之身故或殘廢,如車禍等。
- (2) 團體傷害醫療限額:保障因意外事故所致之醫療,如車禍、跌倒受傷等(不包含感冒、牙痛等疾病),請直接至合格之醫院或診所接受醫療,每次意外事故醫療費用在50,000元內可向保險公司申請理賠。
- (3) 團體住院醫療保險:保障因意外事故或疾病所致之住院醫療,其各項醫療費用限額,請參照上表。
- 5. 保險事故發生時所需之醫療費用應先自行支付,再向保險公司申請保險金給付。
- 6. 理賠申請手續:
 - 1) 填寫表格(申請表格可至國語中心 709 辦公室領取)及檢附醫療証明文件: ①填寫理賠申請書;②檢附合格醫療院所診斷証明書;③檢附醫療收據正本
 - 2) 請備齊上述①~③文件以及護照或 ARC 影印,到國語教學中心 709 辦公室申請。
 - 3) 理賠申請經保險公司審核後,將於15個工作天左右寄送理賠支票至國語教學中心709辦公室,再通知學員或受益人領取。

National Taiwan Normal University: Mandarin Training Center Group Insurance for Foreign Students

 $(2024.09.01 \sim 2026.8.31)$

- 1. The insured: The foreign students enrolled in Mandarin Training Center (hereinafter as MTC) of National Taiwan Normal University will be enrolled into the group insurance plan simultaneously after completing MTC's registration procedure.
- 2. Effective date: The group insurance coverage starts on the first day of each month for students who enrolled in the group insurance plan. (The enrollment procedure will be regulated according to the contract mutually agreed upon.)
- 3. Premium:
 - 1) Regular Class: 3-month period, the premium is NT\$276
 - 2) Summer Class: 2-month period, the premium is NT\$184
 - 3) Single-month Class: 1-month period, the premium is NT\$92
- 4. Details of the group insurance coverage:

Remarks:

- 1) Injuries: Covers death or disability caused by an accident, i.e., car accidents.
- 2) Medical Treatments: Cover medical expenses caused by an accident, i.e., car accidents, (illness, such as catching a flu, and dental treatments are not included). When an injury is caused by an accident, the insured may proceed to a legally registered clinic or hospital for treatment. The medical treatment cost will be reimbursed up to NT\$50,000.
- 3) Hospitalization: Covers the costs of hospitalization caused by diseases or accidents. Please refer to the table above regarding to the maximum reimbursement amount of each hospitalization cost.
- 5. All medical expenses should be paid by the insured in advance, and the insured can then apply for the reimbursement.
- 6. Applying for accident benefits:
 - 1) Fill out the forms (available in Room 709) and enclose documents issued by the hospital, including:
 - **1** The completed Claims Application Form
 - 2 The Medical Diagnosis issued by legally registered clinics or hospitals
 - 3 The Original Receipts
 - 2) Please prepare the documents mentioned above $(0 \sim 3)$ with your passport or ARC copy to apply at Room709 MTC office.
 - 3) MassMutual Mercuries Life will mail the reimbursement checks to Room 709 of MTC within 15 working days after all required claim documents are submitted. MTC will notify the insured or the beneficiary to sign and take the checks.
